I adopt this pet and release Good Karma Pet Rescue, Inc. and its individual volunteers from all personal injury and/or property damage to myself or others associated with this adoption. This pet will not be used for experimental purposes, or any purpose other than as a pet. I understand that if I have given false information or do not follow the terms of this contract, Good Karma Pet Rescue (the Group) will reclaim this pet and start legal proceedings against me, at my expense.

I agree to the following (please initial each item to indicate your understanding):

_____ I will bring this animal into my home and provide it with proper care.

_____ I will treat this animal as a member of the family and it will spend the majority of its time **inside** the home.

_____ I will allow an agent of Good Karma Pet Rescue to investigate the home provided for this animal. The Group **may take custody** of the animal if the agent believes it to be in the animal's best interest.

_____ I will ensure that this animal receives all preventive inoculations annually and monthly heartworm, tick, and flea preventative medication.

_____ I will purchase the rabies license for the pet in accordance with county regulations.

_____ I understand that all fees associated with this adoption are **non-refundable**.

_____ I agree that this animal will be boarded in a safe facility or remain with me during a hurricane.

_____ (CATS) I will keep this cat **indoors** at all times and **will not declaw** this cat.

_____ (DOGS) When outside, I will keep this dog on a leash or in a fenced-in yard (not on a chain or loose).

_____ I agree that if I can no longer keep this pet at any future time, I will notify Good Karma Pet Rescue to give them the first opportunity to re-adopt my pet. **I will never abandon this pet.**

_____ I do not hold the Group responsible for errors in the information provided about this pet. I understand that the actions of animals are often unpredictable, that animals should be **closely supervised at all times**. The Group makes no claims or representations as to the health, temperament, or mental disposition of this pet.

_____ I do not hold Good Karma Pet Rescue responsible for the behavior of the animal and the resulting actions, including damage to personal property and/or injury to persons.

_____ I understand that if the animal should become lost, I will notify the Group immediately.

_____ I permit the Group to reprint or display photographs of my new pet with me.
